

Patio Rental Agreement

Please read the following and initial each line

- ☐ A non-refundable rental fee of \$150 is required at the time of booking.
- ☐ The rental fee covers the duration of 2 ½ hours. An additional rental fee will apply at a rate of \$25 per half hour if your events exceed your time limit.
- ☐ You have the option to bring in your own decorations for the occasion. We do NOT allow glass, chewing gum, or confetti on the patio area. Balloons and tablecloths will be provided.
- ☐ Putt'n Around reserves the right to charge an incidental fee depending on any damages made to items, rental area, or property.
- ☐ With the purchase of our rental space, golf comes at a discounted rate. The cost per attendee is \$10 for 18 holes or \$15 for 36 holes (excluding sales tax). Children 4 years and younger are \$6 for 18 holes or \$9 for 36 holes. The cost of your admission is payable on the day of your event, along with any additional concessions that are consumed. Specials, coupons, or discounts cannot be combined with any event.
- ☐ All children 15 and under MUST always be accompanied by an adult during the event, including while golfing. Staff is not responsible for the supervision of minors.
- ☐ Putt'n Around offers an A la Carte menu for events, on the occasion you would like to cater any outside food of your choosing, there will be a fee of \$5 per person attending the event, (with the exception of desserts).
- ☐ Putt'n Around is not responsible for uncooked or food borne illness from items brought in.
- ☐ All food off the a la carte menu must be ordered at least 5 days prior to the event date. Items on the A la Carte menu are subject to availability. There is no guarantee that the requested food items ordered on the day of your event will be available.
- ☐ All beverages, including beer and wine (in compliance with Florida State Law), must be purchased through Putt'n Around. It is not permitted to bring any outside beverages.
- ☐ Pre ordered food is not refundable under any circumstance.
- ☐ If a minimum of 2 hours' notice is given for cancelation or inclement weather, a future party date can be requested without any additional fees (except for pre ordered food). If less than 2 hours or no notice is given to cancel a reserved event, the original rental fee is forfeited with no option to reschedule.
- ☐ It is the responsibility of the client noted in this agreement to ensure that all their guests are adhering to the rules. Putt'n Around reserves the right to evict non-abiding guests at any time with no refund.
- ☐ Confirmation of the number of guests is required 72 hours in advance of party.
- ☐ A 20% gratuity will be applied to the sub total of your party upon checkout for the setup/breakdown of the event and services provided by staff.
- ☐ A credit card must be provided upon arrival for any purchases made during the event. If you wish to pay cash, you may do so at the end of the event and your card will be returned.
